I, _____ [name of foster applicant] make the above statements and voluntarily enter into this agreement to provide a temporary home as a foster caregiver to any animal(s) SAFE PAWS RESCUE may temporarily place in my care.

- I agree to provide a SAFE PAWS RESCUE representative access to all parts of my home and property for a home inspection before my application to foster is approved.
- I understand that I may be required to provide foster care to my foster animal(s) for an extended and indefinite period of time.
- I agree that I am over 18 years of age.
- I understand that SAFE PAWS RESCUE provides no guarantee as to the health of my foster animal(s) and that my foster animal(s) may have medical needs, socialization problems, and may not be housebroken.
- I agree to provide my foster animal(s) with veterinary care as authorized by SAFE PAWS RESCUE and paid for by SAFE PAWS RESCUE.
- I will not arrange or pay for any elective veterinary care for my foster animal(s) without the express consent of an authorized SAFE PAWS RESCUE representative.
- I will take all necessary precautions to prevent my foster animal(s) from either impregnating another animal or becoming impregnated. If that happens, I will notify SAFE PAWS RESCUE immediately.
- I understand that I may only have my foster animal(s) temporarily.
- I agree that I am fostering this(these) animal(s) for SAFE PAWS RESCUE, and that I do not have any right of ownership over my foster animal(s). I further agree that SAFE PAWS RESCUE'S rights in and to my foster animal(s) are superior to mine. I also agree to provide a SAFE PAWS RESCUE representative access to my home and property to check on my foster animal(s), at any time that I am in possession of my foster animal(s).
- I agree to immediately return any foster animal(s) in my care to SAFE PAWS RESCUE at the request of its authorized representative at any time and for any reason. If SAFE PAWS RESCUE is forced to undertake legal action to enforce this provision of the agreement, I agree to indemnify SAFE PAWS RESCUE for all court costs and attorneys' fees connected with such an action.
- If I am planning to move at any time during the period when I am housing a foster animal(s), I agree to contact SAFE PAWS RESCUE prior to my move and provide SAFE PAWS RESCUE with my new contact information. I understand that SAFE PAWS RESCUE has the right to request return of my foster animal(s) based on my change of residence and agree that I will surrender my foster animal(s) to SAFE PAWS RESCUE immediately upon request.
- I understand that if I provide foster care to my foster animal(s) to SAFE PAWS RESCUE'S satisfaction, I will be given the first right of adoption of my foster animal(s), at such time as SAFE PAWS RESCUE decides to place my foster animal(s) for adoption.
- If at any point I can no longer, or do not want to continue to, provide care and shelter for my foster animal(s), I agree to contact SAFE PAWS RESCUE and arrange for surrender and return of my foster animal(s) back to SAFE PAWS RESCUE.
- I will not transfer possession or custody of my foster animal(s) to any other person at any time, except for temporary, short-term possession for vet care, grooming, etc.
- I agree to contact SAFE PAWS RESCUE with all questions or concerns about my foster animal(s) or the Foster Care Program as well as with updated contact information.
- I agree that if I refuse or fail to comply with any provision of this agreement, SAFE PAWS RESCUE has the right to terminate this agreement and has the right to the immediate surrender and return of my foster animal(s). I further consent to provide SAFE PAWS RESCUE access to my premises if necessary to facilitate the return.
- I agree that the opportunity given to me to help rehabilitate my foster animal(s), as well as the chance of a potential future adoption, is of significant benefit to me, and serves as proper legal consideration in exchange for my agreement to the terms of this contract and I hereby fully and completely release, indemnify and hold harmless Safe Paws Rescue, Inc., its directors, officers, volunteers, servants, and employees from any and all claim(s), cause(s) of action or liability of any sort or nature, whether known or unknown, directly or indirectly arising out of or in connection with the foster, care or ownership, maintenance, temperament or condition of the Animal, including any and all physical or emotional injuries or damages which may or could occur from any negligent acts or omissions of Safe Paws Rescue, Inc.

I have read this application and Agreement in its entirety, and I agree that all statements and agreements contained in this document are made by me and are truthful, under penalty of perjury under the laws of the State of Florida.
